



PSB RESOLUTION NO. 2017-003

A RESOLUTION RELATIVE TO THE PROTEST OF MS. AIDA TAPAR TAYAMORA, SENIOR BOOKKEEPER, APPLICANT TO ADMINISTRATIVE OFFICER IV POSITION, ANTIPOLO NATIONAL HIGH SCHOOL

WHEREAS, on June 23, 2017, the Division Personnel Selection Board Chair received an appeal from Mrs. Verzola requesting reconsideration that her submitted Certificate of Participation to the 10th National Assembly and Seminar-Workshop conducted by DepEd NEU be given points under training;

WHEREAS, upon review of the Personnel Selection Board, the appeal was considered for reason that the said Certificate of Participation includes in its title 10th National Assembly and Seminar-Workshop of the Department of Education National Employees' Union;

WHEREAS, PSB Resolution No. 2017-001 was issued and posted in the Division webpage on September 4, 2017, to effect the decision of the PSB as follows:

NOW, THEREFORE, for and in consideration of the foregoing premises upon motion duly seconded, be it RESOLVED, as it is hereby resolved, that points should be given to applicant Verzola under training due to her participation to a National Assembly and Seminar-Workshop, and that the change in total points be reflected in the amended Summarized Ranklist for AO IV applicants from 53.04 to 61.04 due to the addition of 8 points under training;

WHEREAS, on September 6, 2017, the Office of the Schools Division Superintendent received a letter-protest/inquiry from Ms. Tayamora stating the following:

This pertains to the PSB Resolution No. 2017-001, which resolved that 8 points should be given to applicant Pamela M. Verzola in view of her participation to the National Assembly and Seminar-Workshop, thereby adjusted the latter's points under the criterion of training from 53.04 to 61.04.

In view hereof, attached herewith is a Certification issued by Irene Millo, National Treasurer, DepEd National Employees' Union, certifying that the name PAMELA VERZOLA does not appear in the list of participants who paid the registration fee to the 10th National Congress of DepEd National Employees' Union held on November 7-14, 2016 at Teachers Camp, Baguio City.

In the spirit of justice and fair play, your sound determination concerning the entire ranking for the position of Administrative Officer IV, is earnestly requested.

WHEREAS, on September 7, 2017, the Schools Division Superintendent issued a letter requesting the comment of Ms. Verzola on the above mentioned letter, copy furnished Ms. Tayamora;

WHEREAS, on September 13, 2017, the reply of Mrs. Verzola was received by the Office of the SDS, contents are as follows, copy furnished Ms. Tayamora:

Please be informed that it is only upon receiving the certification from NEU treasurer that the undersigned learned that she was not included in the list of participants who paid the registration fee for the 10th National Congress of DepEd National Employees held at Teachers' Camp, Baguio City last November 7 to 11, 2016. Please be informed further that the undersigned entrusted her registration to MR. MADIEL D. VERZOLA who was also a participant xxx with other participants from the Division Office of Antipolo City on Day 0 while the undersigned arrived on Day 1. All the while, the undersigned believed that she was already paid.

The fact that the undersigned has an approved Travel Order and given a Certificate of Participation and Appearance, there was no intention of not paying the said registration.

Please see attached approved travel order and pictures for your reference.

Thank you and hoping that this may help enlighten this concern.

WHEREAS, Ms. Tayamora wrote a letter dated September 25, 2017, acknowledging receipt of the reply of Ms. Verzola, attaching the 10th National Assembly of the DepEd National Employees Union Directory, November 8 – 10;

WHEREAS, the documents submitted of both parties concerned were reviewed and evaluated to resolve issues raised by Ms. Tayamora;

WHEREAS, Mrs. Verzola was allowed to attend the 10th National Congress and Seminar-Workshop of DepEd NEU on Official Time Only, as evidenced by approved travel order attached in the latter's reply;

WHEREAS, Mrs. Verzola was physically present during the 10th National Congress and Seminar-Workshop of DepEd NEU on November 8-11, 2016, as evidenced by attached pictures, which may be attested by Division Participants to the said congress;

WHEREAS, DepEd NEU National Treasurer, Ms. Irene Millo issued a certification that Mrs. Verzola did not appear in the list of participants who have paid the registration fee, in which Mrs. Verzola explained that she was in the belief that her registration fee was already paid by Mr. Madiel Verzola, and has no intention of not paying the same;

WHEREAS, the 10th National Assembly of the DepEd National Employees Union Directory, November 8 – 10 attached in the letter of Ms. Tayamora dated September 25, 2017, cannot be given weight as this does not prove or disprove any of the claims of both parties, for reason that the name of **Mrs. Christine T. Coronado** appeared in the said directory, when in fact, she was not able to attend due to her attendance to a different seminar/workshop held on the same dates;

WHEREAS, DepEd Memorandum No. 70, s. 2016 RE: 10th National Assembly and Seminar-Workshop of the DepEd National Employees Union, paragraph 5 and 6, requires all participants to pay registration fees;

WHEREAS, non-payment of registration fees may invalidate official participation to any event/seminars;


NOW, THEREFORE, for and in consideration of the foregoing premises upon motion duly seconded, be it **RESOLVED**, as it is hereby resolved, that Ms. Pamela M. Verzola is not an authorized participant to the 10th National Assembly of the DepEd National Employees Union due to her failure to pay necessary registration fee;


RESOLVED, that points given due to her participation to the 10th National Assembly be stricken off, and that that her points under *Training* be revised from **8 to 0**, and that changes in total points be reflected in the amended Summarized Ranklist for AO IV applicants from **61.04 to 53.04**;


RESOLVED, FURTHER that copies of this RESOLUTION will be given to the members of the Personnel Selection Board and concerned parties for their information and guidance;


RESOLVED, FINALLY that this RESOLUTION will be submitted to the Schools Division Superintendent for his notation.


