

The Department of Education Region IV-A CALABARZON, through the Curriculum and Learning Management Division (CLMD), announces the **changes in schedule** of the conduct of the Cliniquing of 2018 NSPC Qualifiers – Individual and Group Contests (Phase 2) from January 29- February 2, 2018 to **January 31-February 4, 2018**, 8AM to 6PM daily at Tagaytay City Science National High School.
