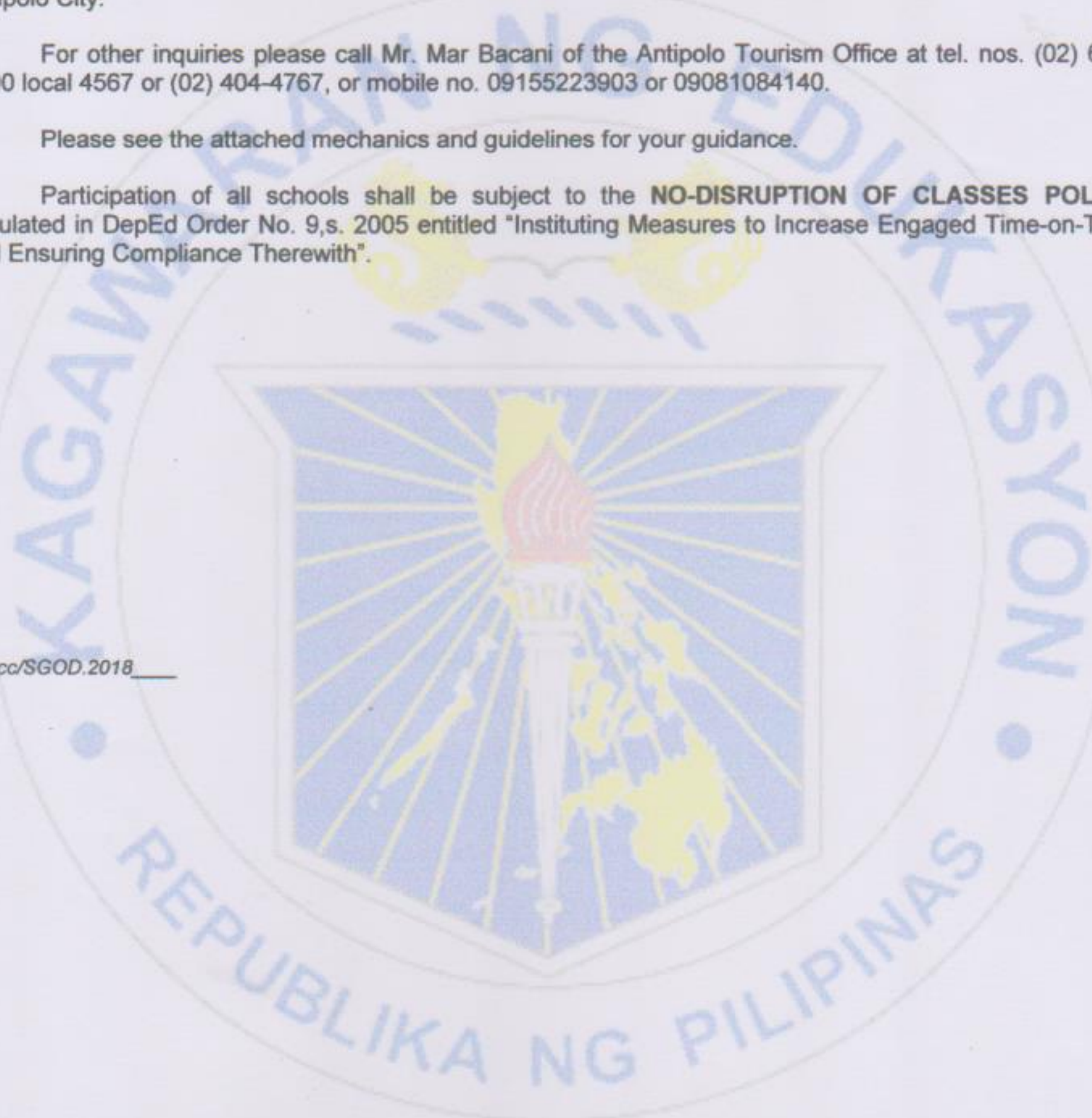
CITY GOVERNMENT ARTS MONTH PAINTING CONTEST

1. The Event is open to all Antipoleños, artists, students and out of school ages 13 years old and above
2. No registration fee
3. Size of the canvass is 18 x 24 inches. Each participant may use either oil or acrylic paint
4. Canvass will be supplied by the organizers
5. Interested parties may submit their pre-qualifying sketch in OSLO paper landscape orientation
6. With the theme:
 - GROUP A AGES 13 to 15 years old Grade 7 to 9
"Make fun with paint, not with fire"
 - GROUP B AGES 16 to 18 years old Grade 10 to 12
"A journey thru the glamour site of Antipolo City"
 - GROUP C AGES 19 years and above open category
"An Art a day keeps Cancer away"
7. Last day for submission of pre-qualifying sketch will be on February 8, 2018, 5:00 pm at City Tourism Office 2nd floor GAD Bldg. Carigma St. Brgy. San Roque, Antipolo City
8. Top 10 entries per category will be selected and will submit their final art-piece on or before February 16, 2018
9. Awarding ceremonies will be on February 25, 2018 during the closing ceremony of Arts Month at the Mall Atrium, Robinsons Place, Antipolo 2:00 pm.
10. All finalists & winning entries shall become the property of the Antipolo City Government.
11. All entries must be signed by the artist
12. The decision of the Board of Judges is FINAL and IRREVOCABLE.
13. The judges will choose top 3 winners, for Group A, B & C
