

- Engagement in work that has positively affected the lives of women and children (25 points)
- Professional excellence and integrity in their respective fields of endeavor (25 points)
- Leadership, including moral rectitude, innovativeness and pioneering spirits (25 points)

- b. no more than 5 letters of support from individuals or organizations.
