



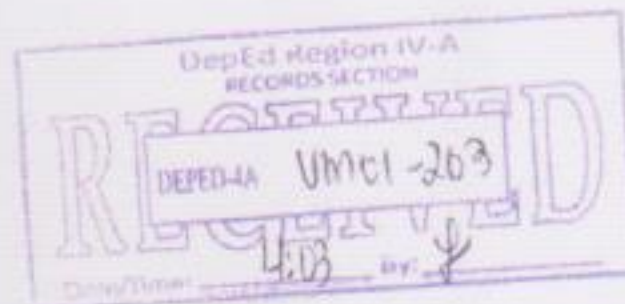

**SUBJECT :** CONDUCT OF THE K TO 10 TRAINING OF TEACHERS ON  
CRITICAL CONTENT

**DATE :** MARCH 21, 2018

The Bureau of Curriculum Development (BCD) with the National Educators Academy of the Philippines (NEAP), Bureau of Learning Delivery (BLD) and the Teacher Education Council Secretariat (TECS), in coordination with the Regional Offices (ROs), shall conduct the **K to 10 Training of Teachers on Critical Content**. This training shall be conducted in two phases: Phase 1- National Training of Trainers (NTOT), and Phase 2- Training of Teachers (TOT).

While the Bureau shall spearhead the National Training of Trainers, the Region shall manage the Training of Teachers by self-administration or through its Schools Division Offices to be conducted as soon as the NTOT is completed. To provide the Regions with a concrete understanding of their Terms of Reference and inputs in the preparation of the Regional implementation Plan, the Bureau shall conduct the Orientation of Regional Management Teams on April 8 to 11, 2018 at ECOTECH Center, Cebu City. In the meantime, the Bureau has initiated the downloading of funds to the Regions for the aforecited Region-led TOT through the Budget Division of the Central Office.

Such being the case, may we request the Regional Offices to commence with the procurement process for the conduct of the TOT so that we can finish the said activity before the opening of classes for SY 2018-2019. However, please be advised to defer the awarding of contracts pending the receipt of the Special Allotment Release Order (SARO) for the purpose so as to comply with the provisions of RA 9184.

Attached, for your reference, is the approved Authority to Conduct with the budget breakdown.
