





3rd QUARTER NATIONWIDE SIMULTANEOUS EARTHQUAKE DRILL (NSED)

4. On August 16, 2018, share your earthquake drill experience by posting photos or videos on social media joining the earthquake drill, with #BidaAngHanda and #DepedAntipoloHandaTayoLigtasTayo.

12. All chemicals in laboratories were secured in cabinets or on shelves to prevent fire.			
13. The drill participants bring first aid kit or any item noticeable during the evacuation phase.			
14. The drill participants conducted the headcount during the headcount phase.			
15. The evacuation area is big enough to accommodate the evacuees.			
16. The drill participants vacate the building and observed the time to reach the designated evacuation area.			
17. The drill participants stay in the evacuation area without instruction.			
18. The drill participants move to another place without instruction.			
19. The drill participants went back to the building without instruction.

2. The 3rd Quarter Nationwide Simultaneous Earthquake Drill(NSED) will be conducted on **August 16,2018, 2:00pm** with the **Regional Ceremonial Venue at the First Philippine Industrial Park(FPIP), Barangay Sta. Anastacia, Sto.Tomas, Batangas** with the aim to inculcate the importance of being prepared sudden strike disasters. In line with this, the RDRRMC is encouraging everyone to conduct drills in their respective offices and areas of responsibility and include the following actions that are relevant to the drill:

2.1 The widest dissemination of the activities utilizing the tri-media in your respective Areas of Responsibility (AOR) and hanging of streamers/tarpaulin in support of the advocacy utilizing the attached format of tarpaulin.

2.2 Uploading of activity and action photos in social media platforms and other advocacy material relevant to the conduct of the drill and disaster preparedness especially for geologic(earthquake) hazards.


2.2 The **simultaneous setting off of alarms/sirens at exactly 2:00pm** that signals the start of the Earthquake Drill. All available sirens particularly of fire engines and ambulances shall be utilized to be able to catch the attention of people in a wide area.

2.3 The testing, validating and evaluating of Local Contingency Plans and Office/Agency evacuation and contingency plans.

2.4 The people should be informed that upon recognizing the signal, they should execute the **DUCK, COVER and HOLD** procedure even inside their homes/work places then proceed to locally designated evacuation areas

3. All concerned are requested to submit their After Activity Reports (AAR) to OCD IV-A through email ocd.rdrmmc4a@yahoo.com / ocd4atraining@gmail.com NLT August 27, 2018 for subsequent submission to OCD-NDRRMC.
