
In line with this intent, we would like to request for an appointment. We wish to explain the following proposals:

Please find samples of international publications we would like to share with your school.

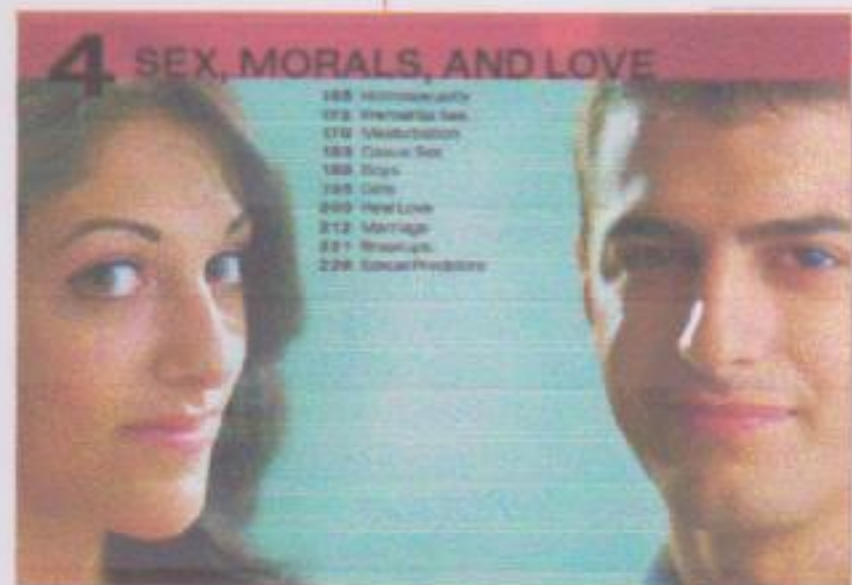
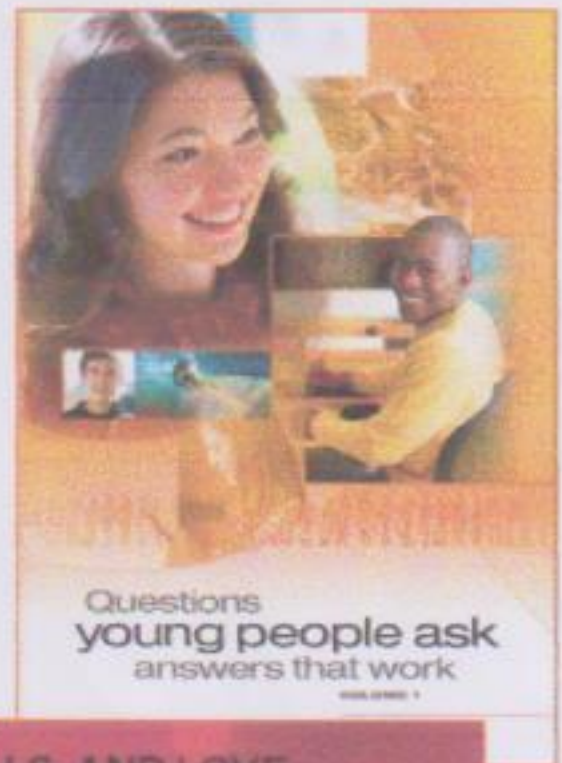
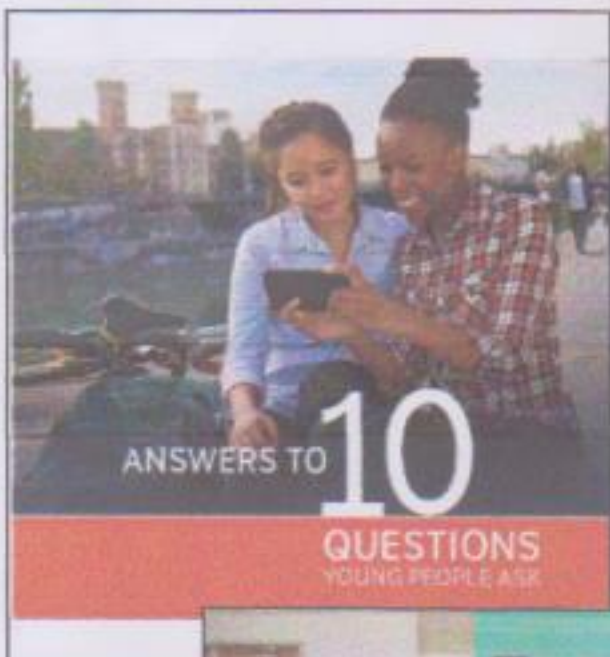
