1. DepEd Region IVA Calabarzon in collaboration with The Teacher's Gallery (TTG) and the Regional Association of Schools Superintendents, Inc. will hold a retreat-workshop entitled, "The Power of a Teacher's Heart: It Can Change A Student's Life. It Can Change the World" this 17-19 October 2018 at Tagaytay Haven, Ulat Road, Tagaytay City.
2. The retreat-workshop will focus on values formation – a combination of mindfulness practices and a wellness guide focused on the following areas: physical, occupational, emotional, financial, and spiritual. It will guide the teachers go through an inventory checklist and a change organizer developed by the author of The Power of a Teacher, Dr. Adam Saenz. Apart from being a psychologist and therapist, he is a professor and once a teacher in K-12, and most importantly an advocate for maximizing teacher impact in classroom.
3. Participants to this retreat-workshop are Education Program Supervisors, Public Schools District Supervisors and School Heads.
