DEVELOPMENTAL COACHING AND PERFORMANCE VALIDATION OF MTs AND HTs

1. Pursuant to DepEd Order No 2 s. 2015 or the Results – Based Performance Management System (RPMS), DepEd Order No 42, s. 2017 or the Philippine Professional Standards for Teachers (PPST), and ISO 9001:2015 certified process on performance and developmental coaching (KRA 4), this Office through the Curriculum Implementation Division, announces the conduct of Developmental Coaching and Performance Validation of Master Teachers and Head Teachers (Junior and Senior High) for the 4th Quarter of School Year 2018-2019.
2. The activity shall validate the data gathered and the feedback provided during the Instructional Leadership Training for Master Teachers and Head Teachers in Junior and Senior High Schools held in Loreland Resort last December 2018.
3. Schedule of classroom observations shall be coordinated with the school heads and concerned master teachers/ head teachers at least a week before the actual observation in accordance with the RPMS-PPST protocols.
4. MTs and HTs to be observed shall be given a certificate of participation for developmental coaching while teachers to be observed shall receive certificates of recognition as Division demonstration teachers, whose names shall be issued on a separate Division Bulletin.
5. The Curriculum Implementation Division (CID) supervisors to facilitate the developmental coaching and validation shall be organized in flexible groups depending on the learning area and districts where MT or HT belongs.
6. Wide dissemination of this memorandum is desired.
